"Declares the said Lot of property of Fifty-Six square perches to be held in trust , neverthless, that they the 88 said Trustees shall and will/soon as they can conveniently next build and finish upon the said granted Lot a House or Building of such size, form and dimensions as they, the said Trautees shall think fit, which said house or Building shall when completeda, be used and occupied as a school house for the instruction therein of children and others in the useful branches of school learning, commonly understood by the description of the lower branches of an English education, and also. shall moreover be used and occupied as an occasional place of worship for the use and service of the professors of Christianity of every denomination in the delebration of Divine Worshipwho shall have the right and privilege from time to time to meet and assemble therein for the adoration and worship therein of Almighty God the creator. Upholder and Ruler of the Universe, and that the said House or Building shall only be used and occupied in the manner and for the several purposes aforesaid from time to time, and forever. and upon this further trust --- that the trustees or their successors in the said trust, may repair, alter, rebuild the said House or Building at their will and pleasure, from time to time, so always, however, that this present grant shall only enure to and for the uses and purposes above mentioned. And it is hereby especially declared and agreed upon and understood that the said Trustees and their successors in the said Trust shall forever hereafter at their own proper costs and charges

Record of the Charter of the Falls of Schuylkill Association,

To All To Whom these presents shall come The Commonwealth of Pennsylvania sends Greetings Whereas an Association by a number of citizens of this Commonwealth has been formed in Penn Township; Philadelphia County, and State of Pennsylvania, and a building has been erected by private contributions on a lot of Ground presented To the Association situate on Bowman's Jane near the Falls of Schuylkill, in the said township, for the purpose of a School and a place of Divine Worship to which it is now appropriated. AND WHEREAS at a Meeting of the said contributors the following genelemen were duly elected Trustees of the said Association, viz., William Alexander, Isaac Salkeld, Joseph Sorber, Isaac Johnson, Frederick Stoever, Jr., Robert Watkins, Charles V. Hagner, Godfrey Shronk and William Briggs, to whom the care ond the management of the same was delegated.

AND WHEREAS it has been deemed expedient and for the

interest of the said Association that it should have and receive the powers and immunities of a corporation, or body politic in law under the name, stile, and title of The Falls of Schuylkill Association, THEREFORE know Ye that the said William Alexander, Isaac Salkeld, Joseph Sorber, Isaac Johnson, Frederick Stoever, Jr., Robert Watkins, Charles Hagner, Godfrey Shronk and William Briggs, Citizens of the Commonwealth of Pennsylvania, and such other persons as shall hereafter become members of the said Association, and their successors, shall be and they are hereby and by force and virtue of the act of the general Assembly of this Commonwealth, entitled "An Act to confer on certain Associations of the Citizenssof the commonwealth the powers and immunities of Corporations or bodies politic in Law", passed the Sixth Day of April A.D. One Thousand Seven Hundred and Ninety-One, made, declared, and constituted to be a Corporation or body politic in law and in faith, to have continuation forever by the name, style and title of The Falls of Schuylkill Association, under the articles and constitution following, viz:

16

ARTICIE 1st. Every Person paying the sum of Four Dollars shall be considered a member of the Association.

ARTICLE 2nd. The whole business of the Association shall be under the management of none Trustees, Viz: William Alexander, Isaac Salkeld, Joseph Sorber, Isaac Johnson, Frederick Stoever, Jr., Robert Watkins, Charles V. Hagner, Godfrey Shronk and William Briggs, and their successors to be chosen at such times and in such manner as shall hereafter be directed.

ARTICIE 3rd. The three persons first named of the

aforesaid Trustees, shall continue in office until the first Monday in January in the year One Thousand Eight Hundred and Twenty. The three next named of the aforesaid Trustees shall continue in office until the first Monday in January in the year One Thousand Eight Hundred and Twenty-One, and the three last named of the aforesaid Trustees, shall continue in office until the first Monday in January of the year One Thousand Eight Hundred and Twenty-Two, the places of those Trustees whose time of service shall expire agreeably to the provisions of this article shall be supplied by an election of an equal number of persons annually on the first Monday in January.

ARTICLE 4th: The aforesaid Trustees shall choose a President, Secretary and Treasurer, either from their own number or from the Association at large. They shall keep a regular and fair record of their proceedings which shall at all, times be open to the inspection of any member of the Association and on the first Monday in January annually they shall lay before the Association a report of their proceedings and an account of their receipts and disbursements.

ARTICLE 5th: The Trustees shall have the sole power of choosing a suitable teacher, or Teachers of the School, fixing the price of tuition, of inviting any regular **Tracker** Preacher of the Gospel of any denomination to officiate in the room appropriated to religious worship and generally to regulate everything relative to the Schoolhouse and Meeting Room for Worship.

ARTICLE 6th: The aforesaid Corporation shall have the power to take, receive, and hold all and all manner of lands,

rents, tennements, annuities, and hereditaments, or any sum, or sums, of money, goods and chattels, of whatsoever kind that may be given or bequeathed unto them to be used and employed and disposed of in supporting a School, or Schools, or in supporting the Gospel and providing and keeping in repair the Buildings for the aforesaid purposes, PROVIDING ALIWAYS that the clear yearly income of the messuages, houses, lands, rents, annuitizes and other hereditaments of the said Corporation and the interest of money lent by them do not exceed the sum of five hundfed pounds.

ARTICLE 7th.The said Corporation by the name and style aforesaid are hereby declared and made capale in Law to sue and be sued, to plead and be impleaded, answer and answered, defend and be defended in any Court, or Courts, or other places and before any Judge, or Judges, Justice, or Justices, or other persons whatsoever in all manners of suits, auctions, of and pleas/whatsoever kind and nature they may be in as full and effectual a manner as any person, or persons, or other bodies politic may or can do.

ARTICLE 8th. The said Corporation shall have power to make, have, and use one common Seal with such device and Inscriptions as they shall think proper and the same to break, alter and renew at their pleasure.

ARTICLE 9th: The aforesaid Trustees and their successors shall have full power to make Rye-Laws, Rules, and Ordinances for the transacting of their own business and for the government of the Association, and the same to be put in execution, revoke, or diannul, alter or annul at their pleasure PROVIDING ALLWAYS that such Rye Laws, Rules and Ordinances

be not repugnant to the constitution and laws of the United States, to the Constitution and law of this State, and to the provisions of this Instrument.

ARTICLE 10th. It is neverthless provided that in inviting any regular Preacher of the Gospel to officiate agreeably to the Fifth Article, no preference shall ever be given to any particular persuasion, or denomination, but arrangemenys shall be made so ministers of all the different denominations of Christians may officiate in regular succession from time to time.

IN TESTIMONY WHEREOF, we have hereunto set our hands and seals this 13th day of July, in the year of our Lord One Tjousandm Bight Hundred and Mineteen.
